CONDITIONS APPLICABLE:

CANCELATIONS

10% Of total quote amount Cancellation fee will be charged once order was received and customer requested cancellation.

STORAGE

Any hoist, motors, lifting equipment etc. which is declared uneconomical to repair, will be kept safe up to a maximum period of 3 months on our premises, if not collected within this period CCC will have the right to discard the above-mentioned equipment.
